I am aware that skiing and snowboarding involve many risks, dangers and hazards including, by not limited to: boarding, riding and disembarking ski lifts; changing weather conditions; avalanches; exposed rock, earth, ice, and of er natural o ects; trees, tree wells, tree stumps and forest deadfall; the condition of snow or ice on or beneath the surface; variations terrain may create blind spots de or artificial s or areas of reduced visibility; variations in the surface or sub-surface, including changes due to ma w; variable and difficult conditions; streams, creeks, and exposed holes in the snow pack above streams or creeks; snowcat rg as, road-banks or cats, syswmobiles or other cut-banks; collision with lift towers, fences, snow making equipment, snow grooming equipment, thin one's own ability vehicles, equipment or structures; collision with other persons; loss of balance or control; failure to act san r persons; and NEGLIG CE ON THE PART OF or to stay within designated areas; negligence of other skiers, snowboarders and E PEASONABLE STEPS TO EASEES TO TA THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE P S REFERRE TO ABOVE. ## RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMN AGREEMENT

In consideration of the Releasees accepting my application as Season and permitting my use of the lifts, ski runs, trails, terrain parks, race courses, restaurants, day lodge and other ski to cilities (he after "the facilities"), and for other good and valuable consideration, the receipt and sufficiency of which is acknowed as thereby again, follows:

1. - 3. This Agreement shall be effective and bird g upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacit.
- 4. This Agreement and any rights, ties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Provice of Alberta and no other jurisdiction; and
- 5. Any litigation involving the parties to this Agreement shall be brought solely within the Province of Alberta, and shall be within the exclusive jurisdiction of the Courts of the Province of Alberta.
  - In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees with the respect to the safety of skiing or snowboarding other than what is set forth in this Release Agreement.
- The Season Pass issued to the Passholder is the property of PASS POWDERKEG SKI HILL, is not transferable, not for resale and is revocable for misconduct or breach of the Alpine Responsibility Code.

I HAVE READ AND UNDERSTAND THIS RELEASE AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
